

Gender dimensions of poverty in Bangladesh (2004) if the dowry does not correspond to what the bridegroom or his parents demand the marriage fact can be broken off, in which case the family of the bride is socially blamed. As protection against utter emptiness should she lose her husband through separation or death, under Islamic law in Bangladesh girls can lay claim on a certain sum for him, the mohorana, to be to be given her either when she marries or in case of divorce. But this does not happen either first because many women are not aware of this right and second because insisting on it would expose a woman to social censure and risk of losing her husband's good will. If women do demand the mohorana in case of divorce then her chances of remarriage plummet.

The prevalence of dowry was reaching such a horror even in the face of unemployment, depression and crisis of proper moral education. Apart from that obsession with superstition and ambitious mentality can also be identified as the reason.

2.4 Recent changes in dowry system

In that time gambling has become rampant. He just changed. Once upon a time there was a system of collecting money from hand to hand. Wedding ceremony, the boy would take care of the entire dowry and when the debts and debts were settled, the bridegroom would be brought to the wedding ceremony. Besides any breach of contract on the part of the bride while accepting the dues was considered a felony and it was very common to take the boy away from the matrimonial home for this crime alone.

Present society apart from huge amount of money, flat house or luxury car with TV, fridge, expensive furniture etc. demanded. The cost of sending the son abroad or the agreement to put him in a job also made as dowry. Despite all this, the daughter's father cannot be exempted. Again, and again various pressures started coming from the law.

The girl's guardian gets a pass mark in fulfilling the requirement then the wife is Lakshmi. And if the guardian of the girl is disabled then started torture and do in human torture start. Wife speech and all activities are untouchable like bitter fruit. The murder plot starts with severe mental and physical torture to the victim. Sometimes helpless girl had to be brutally killed.⁸ After the murder, the body was hung from a ceiling fan as evidence of suicide or floated in a river or buried under ground the dark of night. If the corpse goes behind the eyes of people, not even a crow will notice. That was the toxic consequence of dowry system.

The answer is that it was happening everywhere, In the village or in the city Village is visible There it was said that if dowry is not given the girl will not get married. If you are older you will be had to pay more dowry but dowry is given and taken. Different customs in the city here the upper classes are running it in various ways like jobs, cars, houses, and banks. We cannot socially boycott the givers and takers.

CHAPTER 3

The law related to dowry in Bangladesh

3.1 The dowry prohibition act of 2018

The dowry prohibition act 2018 creates for stop dowry system in our country. Because without any law the dower system not be stop. This prohibition creates for natural justice. In dower case more the victim is simple family, poor family. The dowry prohibition act 2018 have 11 sections.

According to section 2 says about definition of dowry. and section 3 says about punishment for given and taken dowry. if any person gives and take dowry for this, he shall be liable to imprisonment for a term not sensational five years but not less than one year or to a fine not exceeding 50,000 Taka or both.

Section 5 says about Contracts relating to dowry are void. For the reason of this Act, any contract relating to payment or acceptance of dowry shall be void. Section 6 says about Penalty for filing false cases etc. If any person files any suit or complaint under this Act with intent to injure another person without knowing any just or lawful cause to file a suit or complaint under this Act, he shall be liable to imprisonment for a term not sensational (five) years or to a fine not sensational 50,000 shall be punished with a fine.

Section 7 says about Combustibility of offences, non-bail able. Do Crime under this Act shall be cognizable, non-bail able and negotiable. According to section 8 says about punishment for offence under this act.

3.2 Is people follow dowry prohibition law in BD

When create dowry prohibition act 2018 to stop dowry system. Create for this act more than change dowry system in our country. But some people are not stopped this dowry system they didn't follow the rule of law. For example: May 21.05.2022 dowry reason dead 1 girl. More than family is not published dead reason. They said this is suicide. So that the salutation of our country. It's very disappointing.

3.3 Nari o Shishu Nirjaton Daman Ain 2000 section 2(j), 11

According to section 2 says about women and children act 2000.the definition dowry.

(a) Money, goods or goods claimed by the boon or the boon's parents or any other person directly related to the marriage at the time of the marriage or during the subsistence of the marriage, provided the marriage is subsisting as dowry other assets

(a) Sums paid or agreed to be paid by the bride to any marriage to the boon or the parents of the boon or any other person directly related to the marriage at or before the marriage or during of the marriage, provided the marriage is to survive, equipment or other resources.

According to section 11 Punishment for causing death for dowry.

If the boon of a woman or the boon parents, relative or any other person on behalf of the boon causes the death or attempts to cause the death of the woman for dowry [or causes grievous hurt or simple hurt to the said woman.] If the said boon his parents, guardian, relative or person -

- (a) Shall be punishable with death for causing death or with imprisonment for life for attempting to cause death and in both cases shall be liable to fine in addition to the said sentence.
- (b) For causing grievous hurt, shall be punishable with rigorous imprisonment for life or with rigorous imprisonment for a term not exceeding five years and shall also be liable to fine in addition to the said sentence.

(c) For causing simple hurt shall be punishable with rigorous imprisonment for a term not exceeding three years but not less than one year and shall also be punishable with fine in addition to the said penalty.

3.4 Section 3 of the dowry prevention act 1980

It is said about giving or receiving dowry. After the commencement of this Act under section 3 of this Act, any person who pays or accepts dowry or assists in the payment or acceptance of dowry, shall be liable to imprisonment for a term which may extend to five years and not less than one year or to fine or to both. will be Further, after the coming into force of this Act, any person who directly or indirectly demands dowry from the parents or guardians of the bride or groom, shall be liable to imprisonment for a term which may extend to five years and not less than one year or to fine or to both

CHAPTER 4

Socio Economic Impact of Dowry System in Bd.

4.1 Impact of dowry system in our society.

Dowry is a social custom in which a man and his family demand ⁹wealth and money from the wife family. Dowry is outlawed in India and other nearby countries. The practice is still very prevalent in these regions. In this post, I was going to explain what dowry killing is and how we can prevent dowry killing. 4.2 Dowry killing: why does it happen?

- 1. Once married, it is considered humiliating for a woman to return to her parents' home. A failed marriage is a disgrace to a girl and her family.
- 2. After marriage, women are expected to be submissive, silent and compromise with everything that comes their way.
- 3. Girls haven't the same values and are not moved equally as boys. They don't fall up to be financially independent. Even in the face of misuse many women try their best to bear it because they don't want to be a tall to their parents.
- 4.¹⁰ Women in India often have little or no control and agency over their own lives. This makes them highly weak to injustice and persecution.
- 5. Dowry being illegal in India, little action has been taken to stop the heavy exchange of cash and other assets at marriages. This is a very common practice among all socio-economic classes.¹¹
- 6. The most alarming fact is that, in many cases the girl's parents are aware of the harassment and constant demand of dowry after marriage. They try their best to meet the demands, while pressuring their daughters to adjust and try to be good wives. Saving the girl's

Many reasons behind the practice of dowry from ancient times to the present day. Below are some of the reasons:

(a) Money is greed

Dowry originated as a mindset to gain additional wealth. Large of money is collected from the father who is responsible for the daughter due to financial gain.

(b) Kaulinya tradition

Since ancient times well to do girls used to give various gifts to the groom. These gifts were symbols of their nobility. But with time this practice took the form of compulsory dowry.

(c) Hindu Family Law

Hindu family law girls are not entitled to parental property. Hence, the mentality of demanding large sums of money from the girl's family at the time of marriage is created. Which, intensifies the practice of dowry.

(d) Lack of female education

Women's education was largely responsible for the practice of dowry. Due to lack of education, women are unable to build themselves up. As a result, as women are falling behind on the one hand and is less educated. The Boys family does not hesitate to demand financial resources from the girl's family.

(e) Decay of religious values

Dowry is void for any religion. But due to the influence of high culture and the degradation of religious values, the dowry system has become in the society. Some greedy classes of people are not paying attention to the religious discipline but are looking at the lack of money.

(f) Poverty

Hoping to get rid of the cruel poison of poverty. The grieving father reluctantly hands over the dowry money to the Boys family. The father has to resort to dowry to protect his girl from poverty.

(g) Lack of female dignity

If men and women are equal in the eyes of the law. Women are reft of many chances. Even now in our country, many families think that a female child is a burden. Due to the low social status of women, the practice of dowry has spread in the society.

(h) Too much love

Due to the great affection of the father and mother for the girl child. The son-in-law helps in increasing the dowry by giving wealth to the daughter-in-law for the happiness of Their daughter.

(i) Eligibility criteria

¹³The girl's physical defects, age, lack of beauty or looks etc. the Boy agrees to the marriage by paying a dowry. If the boy is more suitable than the girl, the bride parents pay a large amount of dowry and marry the girl, so the dowry increases.

Dowry system did not arise for any single reason. A number of factors can be attributed to this.

(b) Says your daughter that keeping quiet will make her marriage successful. It's must be stop.

(c) Beware of any inexplicable or fishy injury, wound or illness of a girl after marriage. Don't ignore any signs of corporal or emotional abuse.

(d) Watch for dynamic red flags. Particularly if your daughter continually asks for large sums of money after marriage.

(e) Not force your daughter to go back to her husband if she resists. Attention to your daughter's stress or behavior after marriage.

(f) Please be aware and look out for red flags of a bride being abused in your nearness. Notify family or local authorities and intervene immediately before it is too late.

(g) Help your daughter become independent without feeling burdened. Adorn in her education, not her marriage.

(h) Create acquaintance in your society against dowry.

Girls 18 years old are the legal age of our country marriage. But some family not fallows this. 59% of girls in Bangladesh are married before their

18-year age and 22% are married before the age of 15. Frustule stops this system. Because effect of child marriage boys and girls both. Because when boy's marriage before 18 years old this time he didn't do any work. This reason he claims dowry to his wife family. But when his wife family didn't give dowry then he started torture his wife. So, this system must be stopped

5.4 Islam and dowry system

Dowry is a prohibited act in the light of Holy Quran and Hadith. Islam has prescribed 'Mahar' for the purpose of empowering women and protecting their dignity. Almighty Allah says:

"Give the women their dowry contentedly"

Conventional dowry system, instead of dowry, the daughter-in-law has to pay the money and property of the husband's illegal abdar. Islam does not condone this injustice. Change of name of dowry oppression. Taking advantage of the helplessness of a woman's guardian, injustice is done to her through dowry. **Hazrat**

5.4 Some ideas by reducing the dowry system

Dowry is being used as a tool to force women. Every day some women are legally harassed by this illegal practice. So, this practice must be stopped soon. Below are the ways to reducing the dowry system:

- (a) Expansion of women's education is first of all necessary to prevent dowry system. Educated women grapple for their rights. Educated women are not a burden for society and family but an asset of the country.
- (b) Child marriage must be present in our society. When we see child marriage will happening in a place then we called police and stop the marriage.
- (c) The greed for money and wealth should be abandoned.
- (d) Giving and taking dowry are both equal crimes. So, we must be following the rule of law.
- (e) Increasing social awareness can prevent dowry to a large extent. The negative aspects of dowry must be presented to the common people.

- (f) Dowry is prohibited in all religions. So, we have to be respectful to our respective religions. We must be following our Islamic rule.
- (g) Youth need to change their mind. They must think that dowry is a form of alms.
- (h) There is an anti-dowry law but it is not properly enforced. As a result, those who take and give dowry do not consider it a crime or feel guilty. Proper use of law must be ensured to prevent this practice.
- (i)¹⁷ Since dowry is prohibited in Islam. Its haram for Islam and most of the people of Bangladesh are followers of Islam, anti-dowry campaign should be carried out through imams and clerics of mosques and they should also be aware about it.
- (j) Human rights organizations and NGOs can also campaign against dowry.
- (k) A girl child is not a burden but she can also be the wealth of the country, such a thought should be nurtured in the heart of the parents of family.

- (n) The women family should come out of thinking that if dowry is given, the girl will be better life off the boy house. This mentality must be changed.
- (o) Anti-dowry reports should be printed in paper magazines.
- (p) Textbooks should include articles on dowry. Then people know about the dowry system.

That is very difficult to eradicate dowry system easily from the society. Need everyone cooperation. Girls should wake up. We must be change you're thinking power. Men's violence in the society is bound to reduce to a great extent if they develop their inner strength instead of thinking of themselves as commodities. If necessary, the call of girl's liberation movement should be spread and social value and status should be acquired by learning. In this way, the pain of the poison-wound of the banking system will be gradually relaxed.it is possible to stop dowry by following this process.
