ABSTRACT

This Internship report is prepared on the basis of my 2 month's practical experience at the hospital of Radda MCH-FP Centre Mirpur Rd, Dhaka. The purpose of this study was to evaluate how often children aged 0-23 months in Radda MCH-FP Centre Mirpur Rd, Dhaka, used the growth monitoring and promotion program, as well as any associated characteristics. Two months internship, I chose 100 kids overall using a straightforward random sampling method. Structured, previously tested, and interviewer-administered questionnaires were used to collect the data. A total of 100 respondents—a 98% response rate—have taken part in this survey. 82 (82%) of the study's participants were primarily locals (Dhaka residents). I have explained the details of the finding in the different file (Project)

Chapter-1

Introduction

The majority of the world's nations have very low rates of attendance, promotion, and educational performance in relation to GMP, and mothers have a difficult time understanding the growth chart. The relationship between the establishment of GMP programs and subsequent changes in healthcare practices has not been well studied. Effective growth-monitoring initiatives are difficult to put into practice, and local conditions are not frequently taken into account when deciding whether to include growth monitoring in national plans. Mothers' illiteracy, poor parental intention for GMP, health staff misinterpreting the chart, and mothers' bad intentions for service users were some of the variables for GMP utilization that were identified in response to many pieces of evidence of poor growth monitoring.

To enhance children's nutritional status, the government of Bangladesh is undertaking growth monitoring and promotion (GMP) through community clinics (CC). On the effectiveness of GMP when provided through CCs, there is, however, limited primary evidence. In order to improve the nutritional health of children under two years old, I want to assess the impact of GMP activities bolstered in CCs spending some quality time of two months at Radda MCH-FP Centre Mirpur Rd, Dhaka

2.1 Organization Profile

An international NGO, Radda Barnen (formerly the Swedish Save the Children), began running the Center in 1974 as a project to provide maternity and child health care for the neglected and impoverished residents of Mirpur under Dhaka Metropolitan City.

Radda Barnen handled its operations for the first twenty years and contributed almost all of the finance. In September 1994, Radda Barnen transferred complete operational and management control of the Center to a new organization with the blessing of the Ministry of Health with the intention of maintaining and consistently enhancing the quality of the services offered by the Center.

3.3 Funding

As an initiative to provide maternity and child health care for the neglected and disadvantaged people of Mirpur under Dhaka Metropolitan City, Radda Barnen (the then Swedish Save the Children), an international NGO, started operating the Centre in 1974.

During the first twenty years of its existence, Radda Barnen oversaw its operation and provided practically all of the funding. With the Ministry of Health's approval, Radda Barnen transferred full operational and managerial control of the Center to a new organization in September 1994 with the goal of sustaining and continuously improving the quality of the services provided by the Center.

Chapter 4 Functions & Service

4.1 Functions

Child health service:	 Treatment of common diseases of children (From birth to 18 years). Treatment of Pneumonia and Diarrhoeal diseases. EPI immunization in every day (except Friday and Govt. holidays). Management of acutely malnourished children aged 0-5 years. Growth Monitoring of children from 0-5 years. Nebulization and Oxygen Inhalation.
Maternal health Service:	 Service for pregnant mother and tetanus toxoid vaccine. Postnatal care with vitamin A capsule. Management of RTI/STI and general diseases of the woman. Family planning services. Tetanus toxoid (TT) vaccination of woman aged 15-49 years.
Regular health and nutrition education:	 Promotion of exclusive Breast Feeding. Complementary feeding practice. Education on health, nutrition and hygiene. Advocacy and counseling on prevention of HIV/AIDS.
Pathological tests (with fixed value):	Blood CBC, Blood film, Platelet Count, Circulating eosinophil count, Blood grouping and Rh factor, Blood Sugar estima- tion, Blood Urea, Serum Creatinine, HBA1C, Widal test, ASO titer, Malarial parasite, Bleeding time, Coagulation time, Lipid Profile, Alkaline Phosphatase, Serum Bilirubin, Serum Uric Acid, CRP, HBsAg screening, HBsAg Elisa, HBsAb (Antibody detection), HCV, V.D.R.L, ICT for Malaria, ICT for Dengue, Anti H Pylori, MT Test, Thyroid Function Test (T3,T4, TSH), S. Prolactin, Pregnancy test, RA test Urine R/M/E, Stool R/M/E and Ultrasonogram.
Other non EPI vaccines:	Hepatitis B Vaccine, Hepatitis A vaccine, Typhoid vaccine, Anti Rabies Vaccine, MMR Vaccine, Pneumococcal Vaccine, Meningococcal Vaccine (Specially for those people who are going for Hazz and Omrah and for the immigrants), Vaccine for prevention of Rotaviral Diarrhoea, Vaccine for Diarrhoea and cholera, Cervical cancer Vaccine, Chicken Pox Vaccine, Hexa vaccine, Yellow Fever Vaccine, Japanese Encephalitis Vaccine, Vaccine for seasonal flu. (Immunization for seasonal cold, fever, cough).Tetanus Immunoglobulin (TIg)
The routine work- ing hour of the clinics:	From 9.00 a.m. to 5.00 p.m. (Sunday to Thursday) On Saturday 9.00 a.m. to 2.00 p.m. Closed on Friday and Govt. holidays.

MCH-FP service delivery takes place at three levels

- ✓ The Centre(static clinics)
- ✓ The outreach sites including satellite clinics Wards-2, 3, 5, 8, 15 & 52, 53, 54 of DNCC & wards 01, 33, 38, 49, 59 of DSCC
- \checkmark The households (community)

Working Time of the Clinics:

The routine working hours are from 9:00 a.m. to 5:00 p.m. on all days except Friday and government holidays. In addition, the clinics at Mirpur Section-10, 01 & 12 remain open on Saturday from 9:00 a.m. to 2:00 p.m.

4.2 The Service of Center (Static Clinics):

Ward numbers 52 & 54 in Uttara, section 10 of Mirpur, section 1, section 12, Bawniabandh, and section 10 of that same city. These facilities offer a full range of reproductive health services, including:

a) antenatal care with tetanus toxoid (T.T.).

- b) Vitamin-A postnatal care for nursing women.
- c) Clinics and home-based health and nutrition education for women and their family members.
- d) RTI and STD management and treatment.

e) Promoting family planning and offering eligible couples contraception through counseling and motivation.

f) Tetanus Toxoid (T.T.) vaccination of females between the ages of 15 and 49.

g) Treatment of all women, regardless of their age.

b) Through regular monthly meetings and refresher training, supervision and monitoring of certified Traditional Birth Attendants (TBA) for referral of safe deliveries

I HIV/AIDS, RTI, and STD prevention advocacy and counseling.

j) Breastfeeding promotion.

k) The provision of services for adolescent reproductive health (ARH).

Service for physical therapy.

- m) Services in Dental Care
- n) Controlling obesity and malnutrition with diet.
- o) Assisting with all government-sponsored health care projects

4.3 Children's health Service:

a) Growth monitoring of 0–5-year-olds;

b) nutrition rehabilitation of very underweight children up to age 5 at the nutrition rehabilitation section of the Center.

c) EPI-Immunization against ten infectious

illnesses, such as poliomyelitis, diphtheria, whooping cough, tetanus, hepatitis-B, hib, measles, rubella, and pneumococcal pneumonia in children.

d) Non-EPI vaccines: Hepatitis A and B for all age groups; Hib for children; Typhoid; MMR;

Chicken pox; pneumonia; otitis media;

meningococcal illnesses; cervical cancer; yellow fever; Japanese encephalitis; and AR vaccine for all age groups.

e) Therapeutic care for young children (0–5).

f) Treatment for children under the age of five who are deficient in vitamin A and other micronutrients.

g) The treatment of common diseases in children aged 6 to 18 years.

h) Offer management assistance to kids who are severely acutely malnourished (SAM).



4.4 Training and Research Institute

There is a fully functional training unit with a 30-bed hostel facility. The training department runs a number of courses for other NGO partners and GOB agencies in addition to teaching the Center's own staff.



4.5 Radda Paramedic Institute

Under the auspices of the Ministry of Health and Family Welfare, the Radda Paramedic Institute offers a two-year Community Paramedic Training Course. It has Bangladesh Nursing Council affiliation National and Institute Population of Research and Training (NIPORT) clearance (BNC).



They adhere to an 18-month Family Welfare Visitor (FWVT) curriculum and a 6-month midwifery curriculum, both of which have been authorized by NIPORT and the Bangladesh Nursing and Midwifery Council, as part of a 24-month training program.
