**Serial A/C form:** I arranged the account forms serially through account number so that the next

time can be easily found.

Thanks letter attach: I printed 2 copies thanks letter, 1 copy attached with the account form and

the other one kept in office serially.

Call service: I called the specific clients who had not receive their cheque book for long time.

Others: delivery cheque book, fill up cheque book, helping seniors, signature verifying etc.

the account holders information in the nominee's part. Then I wrote e cheque where the client

## 5.1 Observation of the Study





## **5.2 SWOT Analysis**




