


Figure 5.2.1.1: Survey result about age




Figure 5.2.1.2: Survey result about gender




Figure 5.2.1.3: Survey result occupation

How familiar are you with the concept of 3D visualization in the furniture industry? $_{\rm 15\,responses}$




Figure 5.2.1.4: Survey result about familiar with the concept of 3D visualization




Figure 5.2.1.5: Survey result about user experience




Figure 5.2.1.6: Survey result about user opinion




Figure 5.2.1.7: Survey result about importance for customer satisfaction




Figure 5.2.1.9: Survey result about how 3D vis technology importance




Figure 5.2.1.10: Survey result about using (AR) (VR) technologies




Figure 5.2.1.11: Survey result about adopting 3D visualization technology




Figure 5.2.3:4: Rizom UV interface




Figure 4.2.3:6: Substance Painter interface




Figure 5.2.4:1: Sketch of Bookcase




Figure 5.2.4:2: Sketch of Tea Table




Figure 5.2.4:3: Sketch of Squire Table

4. Storage dressing table:




Figure 5.2.4:4: Sketch of Almira




Figure 5.2.4:5: Sketch of Tea Table




Figure 5.2.5:1: Gantt chart for project timeline




Figure 5.3.1.1: Unwrapped model on Rizom UV




Figure 5.3.1.2: PBR texture sets of table

Import the Model: Launch Substance Painter and create a new project. Import your model into the project by the File > Import menu.




Figure 5.3.2.1: Texturing interface of bookshelf view in Subtance painter

Set Up the Texture Set: create a new texture set by clicking on the "+" icon in the Texture Set List panel.




Figure 5.3.2.2: Texturing interface of Almira view in Subtance painter

5.3.3 Lighting

To lighting furniture model in 3ds max, we follow these step-by-step instructions:

Set Up the Scene: Start by creating an interior scene in 3ds Max. Place the furniture model within the scene at the desired location.

Create Lights: To light the furniture, in 3ds Max, there are several types of lights we use, such as Omni light, Spot light, Direct light.

Position the Lights: We may want to use a spotlight to highlight specific details or a soft, diffused light for a more even illumination. Modify the properties of each light to fine-tune

their appearance and behavior. Ensure that the furniture materials are properly configured to respond to the lighting in the scene.

Render the Final Image: Once we satisfied with the lighting setup, configure the rendering settings in 3ds Max according to your requirements. Adjust parameters like resolution, file format, and quality settings. Then initiate the rendering process to generate the final image or animation.

5.3.4 Rendering

To render a scene in 3ds Max using V-Ray, you can follow these step-by-step instructions:

Set up the Render Output Settings: We go to the Render Setup dialog by clicking on the Rendering menu and selecting Render Setup. In the Common tab, choose the desired image output format (e.g., JPEG, PNG) and set the image size/resolution.




Figure 5.3.6.1: Table close view in Sketchfab




Figure 5.3.6.2: Bookshelf close to open view in Sketchfab




Figure 5.3.6.3: TV cabinet open view in Sketchfab




Figure 5.3.6.4: Almira close view in Sketchfab




Figure 5.3.3.5: Center Table view in Sketchfab




Figure 5.3.6.6: Multiple use of center table view in Sketchfab




Figure 5.3.6.8: Banch and table view in Sketchfab




Figure 5.3.6.9: Round table and tool view in Sketchfab




Figure 5.3.6.10: Reading table view in Sketchfab




Figure 5.3.6.11: TV cabinet view in Sketchfab




Figure 5.3.6.12: Squire shape table and tools view in Sketchfab




Figure 5.3.6.13: Single bed view in Sketchfab




Figure 5.3.6.14: Bookshelf view in Sketchfab




Figure 5.3.6.15: Bed side table view in Sketchfab




Figure 5.3.6.16: Traditional bench view in Sketchfab




Figure 5.3.6.17: Park bench and table view in Sketchfab




Figure 5.3.6.18: Minimalist sofa view in Sketchfab




Figure 5.3.6.19: Center table View in Sketchfab
