## Submission guidelines

The paper must be based on original research, not published or submitted in whole or in part elsewhere, and should demonstrate the author's own analysis. No part of the article should be a reproduction or downloaded material from the Internet. All papers will undergo a peer review process and Editorial Board will handle all submissions according to generally accepted standards'. Our honorable reviewers are selected from different universities and institutions' of Bangladesh and abroad according based on their excellence in their respective research fields. The copyright of the paper will be reserved by the Faculty of Business and Economics, DIU once it is accepted for publication in the Journal. All parts of the manuscript should be typewriting in 12 – font of Time New Roman, 1.5 – space with margins of at least one inch on all sides. Please number manuscript pages consecutively throughout the paper. All articles have all of their references in Roman alphabet. Maximum length of the paper is 7,500 words including abstract, footnotes, acknowledgement and references.

**Keywords** must appear. Keywords spelled out in all caps followed by period, first word capitalized. (e.g. KEYWORDS. Service quality, dimensions, attitude, competence, convenience)

**JEL** (Journal of Economic Literature) Classifications code ought to be mentioned.

**Tables and Figures:** At the initial stage, put all Tables and Figures within the text of the article. However, after the acceptance of the paper, Tables and figures (illustrations) should not be embedded in the text, but should be included as separate sheets or files. A short descriptive title should appear above each table or Figure with a clear legend and any footnotes suitable identified below.

**Reference:** Cite in the text by the author and date (Smith, 1983) Prepare reference list in accordance with the APA Publication Manual, 6th Ed. All articles have all of their references in Roman alphabet.

## Submitting the paper

Please submit the manuscript only in the MS Word format. Submit two copies of the paper; one with name of all authors along with affiliation, email address, contact phone numbers and postal address listed at the top of the submission letter and another copy by deleting the names and contact details of the authors for blind review purposes. Upon the final decision for publication, authors will be advised to submit the paper in the final word format.
